TERMS & CONDITIONS

Pioneer Village School is committed to providing your children with a quality education that encompasses the philosophy and aims of our school. In order to maintain the high standard of our educational programs and to ensure a quality learning environment for students, our fees are set after taking into account the anticipated level of State and Commonwealth Government funding. An annual invoice will be issued at the beginning of each academic year. The school offers alternative payment arrangements for families. In order to pay by one of the alternative payment options, you must advise the school in writing prior to the commencement of Term 1. You may change your arrangement by writing to the School at accounts@pvs.wa.edu.au

APPLICATION & ENROLMENT FEES

<u>Application Process</u> - Parents/guardians can register their interest at Pioneer Village School by completing the Application Form on the School Website <u>https://pvs.wa.edu.au/enrolments/onlineenrolment-form/</u>

<u>Family Enrolment Fee</u> is a non-refundable confirmation enrolment fee that must be paid within 48 hours of your first child being offered a place at PVS. This is a once-only enrolment fee for your family.

ADMINISTRATION FEE

To reflect the increased cost to the school of managing ad-hoc payment arrangements, an administration fee of \$100 will be charged to any families **not** signed up to the school's direct debit provider or paying up front in full.

FAMILY CONCESSIONS & GENEROUS SIBLING DISCOUNTS

Where a family has two or more children enrolled at PVS concurrently, sibling discounts will apply to the tuition fee component. (General levies still apply at the full rate).

- 50% second sibling discount
- 60% third sibling discount
- 100% fourth and subsequent sibling discount

Siblings in K3 or K4 concurrently do not receive sibling discounts.

Families who pay full fees by the **31st of March** will receive a 5% discount on tuition component of fees.

LEVIES

<u>Capital Levy</u> assists with the cost of building maintenance programs. It also contributes toward future building projects. It is an annual fee, paid by all families.

<u>Amenities Levy</u> includes costs associated with numerous testing requirements undertaken during the year, paid per family.

<u>Resource Levy</u> helps meet costs associated with the provision of educational opportunities and materials provided by external companies.

<u>P&F Levy</u> has been included to assist our Parents and Friends committee to raise funds for our children.

Year 5 / 6 Camp a Camp Fee is charged to your account.

Year 3 / 4 Outdoor Education For an Outdoor Education Fee is charged to your account.

Swimming Levy assists with the cost of swimming lessons for PP – Year 6 students.

STATIONERY AND SUPPLIES

All required stationery and supplies will be purchased by the school on your behalf. Families are not required to purchase stationery.

PAYMENT OPTIONS

A single annual invoice will be prepared at the beginning of each academic year. All school fees should be paid through the school's direct debit provider unless paying in advance. A Direct Debit Request form can be completed and submitted online directly from the school's website. <u>https://pvs.wa.edu.au/wp-content/uploads/2023/10/Fat-Zebra-Direct-Debit-form-v3-1.pdf</u>

Please submit the form by the 28th February.

The following payment frequency options can be made directly to the School bank account or by credit card or EFTPOS.

Annual One payment processed by **31**st March will receive a 5% discount on tuition fees.

The following payment frequency options can be made via the school's direct debit provider.

1. Termly Payments

Four (4) equal payments processed quarterly.

- <u>Monthly Payments</u> 10 monthly payments, to be payable each month from March.
 Fortnightly Payments
 - 20 fortnightly equal instalments payable from March.

FINANCIAL SUPPORT

Families in genuine financial hardship may apply for limited financial assistance from the School Bursar. Families are required to re-apply for consideration annually. Fee assistance is confidential.

ABSENCE FROM THE SCHOOL

The school does not allow leave for holidays during regular school time. Under exceptional circumstances, parents may apply in writing to the Principal. However, no reduction of fees will be applied due to absence from school.

FEES NOT PAID

All fees are required to be finalised before the end of term 4 using one of the above payment options. The School reserves the right to take legal action for the recovery of fees not paid. Any expenses, costs or disbursements incurred by the school in recovering any outstanding monies, including debt collection agency fees and solicitor costs, may be charged to the account. Students may not be permitted to commence a new school year unless outstanding accounts have been paid or a special arrangement has been made with the school's Bursar.

NOTICE OF WITHDRAWAL

Families withdrawing from the school are required to give twelve (12) weeks' notice in writing to the Principal (without exception). Families will be required to pay the 12 weeks fees from the date of notice regardless of when they exit the school.
